SAN DIEGO – September 9, 2024 – Kintara Therapeutics, Inc. (Nasdaq: KTRA) ("Kintara") a biopharmaceutical company focused on the development of new solid tumor cancer therapies, encourages all stockholders to vote at the upcoming Special Meeting of Stockholders (the "Special Meeting") to allow for completion of the proposed merger (the "Merger") with TuHURA Biosciences, Inc. ("TuHURA"). As previously announced, Kintara entered into a definitive agreement (the "Merger Agreement") for an all-stock transaction with TuHURA to form a company combining expertise and resources to advance a risk diversified late-stage oncology pipeline.

Pre-Merger TuHURA equityholders are expected to collectively own approximately 97.15% (or 94.55% after giving effect to the issuance of the CVR shares), of the common stock of combined company on a pro forma fully diluted basis. The combined company is expected to operate under the name "TuHURA Biosciences, Inc." and to trade on The Nasdaq Capital Market under the ticker "HURA." The transaction is subject to customary closing conditions, including stockholder approval of both companies, and is expected to close in the third quarter of 2024.
